## ARTIST'S HOME & OPEN STUDIOS

(City of Albany based artists only)

### OUTLINE:

#### THE CITY OF ALBANY SUPPORTS OPEN HOMES AND STUDIOS PARTICIPATING IN THE EASTER ART FESTIVAL

To meet our agreement with the City of Albany, artists need to comply with the following:

1. The studio is formally listed as part of the Easter Art Festival
2. Adequate provision for parking is made available within your boundary
3. You have safe means of access to and from the venue
4. There is no disruption to the amenity of the surrounding area
5. Neighbours have been consulted to ensure they are aware of the temporary listing and every effort will be made to minimise disruption to the neighbourhood
6. Manage and resolve any reasonable complaints
7. You are insured for Public Liability up to \$20m

To assist artists successfully registering their City of Albany based home or studio, ArtSouthWA has provided the following guidelines and pro-forma letters and support.

All applications will come to and be processed by ArtSouthWA.

No applications for permits or contact with the City of Albany will be required.

#### TO APPLY FOR REGISTRATION, YOU WILL NEED TO COMPLETE THE FOLLOWING:

1. **APPLICATION FORM:** This contains your contact details, venue details, opening hours etc.
2. **TERMS & CONDITIONS:** These are the conditions you agree to abide by and requires your signature
3. **SUBMISSION CHECKLIST & FURTHER DOCUMENTS:** This confirms the documents you have supplied will include the above plus the following:
  - 3.1 Evidence of studio/home parking – a google map or drawn layout will suffice. This should show how visitors will park on your property and how many cars can be accommodated.
  - 3.2 Evidence of Public Liability Insurance
  - 3.3 Signed neighbour/agreement letters -proforma supplied below

6. I will do my best to prevent, manage and resolve any reasonable complaints. I understand ArtSouthWA will assist me if a complaint becomes formal. I will act on complaints immediately and keep ArtSouthWA fully informed.
7. I have obtained and provided evidence of my public liability insurance for the venue.
8. I agree to maintain my venue and surroundings in a tidy, safe, and professional manner,
9. I agree to represent the Easter Art Festival, ArtSouthWA and my venue in a professional manner at all times
10. I agree to provide statistics, visitor comments and feedback, plus any further information required relating to complaints at the conclusion of the Easter Art Festival.

### DEFINITIONS

1. **\*Neighbour:** a residence that abuts a fence line, across the road, any person who might be affected by visitors to your venue parking on their verge (within a 60 m radius from your venue)

We suggest contacting all the properties likely to be affected (9-10 properties located around the property (3 deep on the side and 4-6 across the road and to the rear if applicable)

Larger or remote properties are different and we can provide specific advice in those areas.
